Details and Criteria to Access ZYPITAMAG (pitavastatin) through Marley Drug

This offer is valid for eligible patients purchasing ZYPITAMAG and may not be used for any other product. This offer is valid for the purchase of ZYPITAMAG manufactured for Medicure and lawfully purchased from Marley Drug located in North Carolina (5008 Peters Creek Pkwy, Winston-Salem, NC 27127, United States). The 30-day free voucher is limited to one person as a one-time use and is available to customers new to ZYPITAMAG. The unique voucher code located on the front of this card must be presented along with a valid prescription for ZYPITAMAG at the time of purchase. Patients who are enrolled in Medicare, Medicaid, or another state or federal healthcare program may only use this Savings Offer if paying for the prescription covered by this Savings Offer outside of their government insurance benefit, and no claim is submitted to Medicare, Medicaid, or any federal or state healthcare program. How ZYPITAMAG® (pitavastatin) is different

Lowers LDL; Raises HDL

ZYPITAMAG is a moderate-intensity statin that can lower LDL cholesterol by up to **45%**, similar to atorvastatin (Lipitor®) and simvastatin (Zocor®). But at a much lower dose (**4 mg vs. 20–40 mg**)¹.

It also raises HDL cholesterol more than other statins. In the LIVES Study², patients who switched to ZYPITAMAG saw:

- Average HDL increase: 4–7%
- For those with low HDL (less than 40 mg/dL): an increase of 16–28%

Fewer Drug and Food Interactions

Most drugs (about 80%) are broken down by the same liver enzyme system (CYP450). For patients who take multiple medications, this can cause interactions and raise the risk of side effects or liver problems¹.

ZYPITAMAG is metabolized by a separate pathway (UGTs), making it a safer choice with:

- Antiviral medications (e.g., Paxlovid)
- Transplant medications
- CBD products
- Grapefruit juice

Minimal Impact on Blood Sugar

While all statins can raise glucose levels, ZYPITAMAG is linked to lower A1C and fasting blood sugar levels.

In a clinical trial comparing atorvastatin (Lipitor®) and pitavastatin (ZYPITAMAG) in people with type 2 diabetes^{1,3}:

- ZYPITAMAG had only a **2.1%** increase
- Atorvastatin had a 7.2% increase



ZYPITAMAG is suitable for those with high cholesterol.

It may be particularly beneficial if you:

- Struggle to tolerate other statins
- Have pre-diabetes or type 2 diabetes
- Take multiple medications
- Use CBD products
- Have low HDL-C (“good” cholesterol)
